Technical Standard Order (TSO) C142a Approval for Artex A3-06-2863 Battery Pack

As a TSO manufacturer, you are required to report to the FAA any failure, malfunctions, or defect related to your TSO authorization in accordance with the provisions of CFR 21.3. You must also notify the FAA when you no longer manufacture the TSO-approved article, as required by CFR 21.613(b).
